

## **ANNUAL REPORT 2023**

“The LORD is my light and my salvation; whom shall I fear? The LORD is the stronghold of my life; of whom shall I be afraid?” (Psalms 27: 1)

The year 2023 was another year of remarkable growth and togetherness among the Ascension Mar Thoma Church members. Our church community flourished as we welcomed new members, fostering a sense of inclusivity and shared spiritual journey. The year 2023 was marked by significant changes and challenges, and our parish demonstrated resilience and adaptability. Whether it was the continued impact of the pandemic or other societal shifts, our community came together to navigate these changes with faith, strength, and unity.

### **I. OUR PARISH:**

Ascension Mar Thoma Church was officially formed on February 1, 1998 at 9551 Bustleton Avenue, Philadelphia, PA 19115. The church started with 108 families and today by God's grace, we have 232 families. During the year 2000, we purchased our own place of worship at 10197 Northeast Avenue, Philadelphia, PA 19116 and worship began in this place on November 23, 2000. With high spirit and motivation of our members, the new church was built.

Foundation stone was laid on April 10, 2005 and the dedication ceremony of the church was held on March 11, 2006 by Rt. Rev. Dr. Zacharias Mar Theophilus Suffragan Metropolitan and Rt. Rev. Euyakim Mar Coorilos Episcopa, the then Diocesan Bishop. Our parish purchased our own parsonage for our Vicar in 2011 at 3892 Byron Road, Huntingdon Valley, PA 19006. In 2018, we constructed the new parking lot, and in 2019, the

office space adjacent to the Parish Hall, which can accommodate around 150 people, was renovated for Sunday School activities and other needs of the Parish.

The leadership of the following Vicars were instrumental in the growth and development of our church. Rev. Oommen Philip, Rev. Dr. V.S. Varghese, Rev. Dr. P.T. Jacob, Rev. Alexander Thomas, Rev. A.C. Kurien, Rev. M.C. Skaria, Rev. K.E. Geevarghese, Rev. Antony T. Varughese, Rev. Binu C. Samuel, Rev. Jinson K. Mathew and the present Vicar Rev. Bibi Mathew Chacko. We were also blessed to have the leadership of the youth chaplains Rev. Kurien George, Rev. Issac P. Johnson, Rev. Mathew Skariah, Rev. Roy Thomas, Rev. Dr. Philip Varghese, Rev. Dr. Joe Joseph Kuruvila, Rev. Dennis Abraham, Rev. Prince Madathileth, Rev. Thomas K. Mathew over the years. Rev. Jeff Jack Philips Cheravallil is our present youth chaplain.

The Philadelphia Ascension Mar Thoma Church is currently 26 years old.

We have come a long way from our humble beginning in 1998. At present we have 231 families as per the register of The Ascension Mar Thoma Church Philadelphia, and total membership of 966.

Thanksgiving prayers for those celebrating birthdays and wedding anniversaries, special prayers for members starting their family lives, special prayers for newborn babies on their first day at church were offered on Sundays. An average of 350 people attended Sunday services and about 214 people participated in Holy Communion.

We had a total of 52 Holy Communion services and one divine service. Special Holy Communion services were held on Maundy Thursday, Easter Day, Thanksgiving Day, Christmas Day, New Years Eve, and Organization Sundays.

We had members visiting us and participating in our worship services from different parts of the United States and around the world who are family and friends to our members. We express our gratitude and extend a warm welcome to all the visitors who joined to worship with us.

## 2023 Annual Report Summary - Organizations

### Sunday School Annual Report 2023

The Sunday School 2023 report year was from January 1, 2022 – December 31st, 2023. Sunday school was held in person after church service within the time frame of 11:45 am to 12:45 pm. After attending the Sunday worship service, students and teachers joined the first 15 minutes of Sunday School for singing sessions led by Mrs. Simi Thomas (Main Parish Hall), and Mr. Prince Jacob (Annex Hall). The students then proceeded to their classes. Rev. Thomas K. Mathew, our Youth Chaplain, and Neenu Kochamma joined us on the 2nd Sunday of every month for English service and led singing sessions for grades 6 -12. After Thomas Achen and family left, Rev. Jeff Jack Philips Cheravallil and Ginu Kochamma and kids joined us on the 2nd Sunday of every month for English service since May 2023 and led a combined singing session for all grades.

The 2023 Ascension Mar Thoma Church Sunday School executive committee consisted of President: Rev. Bibi Mathew Chacko, Superintendent: Mrs. Shinzy Mathew, Secretary: Mrs. Bindu Daniel, Treasurer: Mrs. Soja George, Regional Rep: Mrs. Susan George, VBS coordinator: Mrs. Susan George, and Committee members: Mrs. Viney Jobin, Mrs. Simi Thomas and Subha Joy. During the report year, Sunday School had 7 committee meetings. The auditors were Mrs. Dhanya Jacob and Mrs. Roshni George. The Sunday school consists of 168 students and 45 teachers including the substitute teachers.

Sunday School Books were given to all Sunday School students for a fee of \$15.00 which was paid either through Venmo (@AMTC-Sunday-School) the Sunday School account or by cash or check.

The Sunday school released a Lenten Devotional booklet on March 12th, 2023, for the 25 days of Lent. The devotions were from Rev. Bibi Mathew Chacko, Teena Kochamma, Rev. Thomas K. Mathew, Neenu Kochamma, and our Sunday school teachers and students based on the theme “Sacrificial Giving: An Outpouring of Love from the Cross”. All wrote various devotions and were put together into a booklet. The Booklets were distributed to Sunday school students and church members. A Lenten devotional booklet cover page design contest was also conducted for two groups; 3rd through 4th grades and 5th through 6th grades, as there were no participants from the higher grades. The winners were Austin Mathew (from 3rd- 4th grades) and Diya John (5th -6th grades). Anu Kalickal Byju Kochamma was the judge.

For the Mission Month in March this year, our Sunday School was able to join hands with an organization called Everywhere Project to support the local community with the prayers and generous support of our parish members. Over 1,000 peanut butter jelly sandwiches, more than 450 hard boiled eggs, juice boxes, cases of water, Chocolate Chip Cookies, Apples, Oranges, Doughnuts, Bagels, Food Cans, Hand Sanitizers, Jackets, Winter Hats, Gloves, Shoes, Socks, clothes were all handed over to Everywhere Project. They distributed all of them to the local community within a very few hours. 80 volunteers worked together to make sandwiches and to pack out all the items. Our Sunday School kids wholeheartedly made 70 packets of personalized gift bags for the less fortunate kids along with bookmarks. Sunday School was able to donate 1,000 dollars that was raised from Lenten booklet donations and other donations to Salem Mar Thoma Mission field in Tamil Nadu, which supports the activities of an organization that offers tuition classes, moral classes, nutritional food and provides school fees for 65 students from 6 different villages.

Sunday School gave a sendoff to Thomas Achen and family on March 12th. A token of appreciation was presented to Achen on behalf of the Sunday School.

Mother's Day was celebrated on Sunday, May 14th after worship service. Roshni George and Siji Skariah coordinated the Mother's Day program. Sunday school children aged from KG through 5th grade sang two beautiful songs for mothers taught by Mrs. Simi Thomas. Mr. Sajo Joy and Mr. Benny Philip put together a video presentation with special messages and pictures from our children to share with the mothers. Ms. Jenna

Samuel and Ms. Hannah Wilson were the MC's. Many other students did the speeches and helped us distribute the gifts; a pen and a notebook. Special thanks from Ascension Sunday school to Roshni, Siji and Simi, Benny, Sajo and the students for giving us a very special Mother's Day celebration.

This year 35 students from 5th to 10th grades registered and participated in an in-person Diocesan exam on May 21st. Out of 35 students, 5 received an A Grade, 6 students received B Grade and 4 students received C Grade. The students were presented with medals and certificates for their achievement.

Bake Sale was held on April 16th and the total amount raised was \$6,123.47.

Sunday school tests were conducted during the academic year. Midterms were held on January 15th and final exams were held on May 7th for all grades.

Sunday School internal competitions were held on June 4th. Judges were from other denominations.

Drawing/Coloring competitions were held on June 11th after service. Memory verse competition was held on May 14th after Sunday school. Bible Quiz competition was done on September 10th after Sunday school.

2023 Junior Senior Conference was from Thursday, June 29th through Sunday, July 2nd at Bryn Athyn College in Pennsylvania. 10 of our Sunday school students were able to attend the conference.

VBS 2023 was held on July 12th through July 15th and the theme was STELLAR: Shine Jesus' light. There were 169 students registered for this year's VBS. Sunday School did a signup sheet to have the whole church in prayer for two weeks prior to starting the VBS. All the half hour slots for 12 hrs each day between June 28th through July 12th were filled within days. A total of 75 volunteers including the students from 9th grades and up assisted in all different areas from teaching to cleaning. The blankets that were made during the craft session by the VBS students, donated books new and gently used from the VBS students, and toothbrushes were given to OHAAT which is an organization that helps the poor kids with bedding. In addition, our Sunday School sponsored the VBS for St. Paul's Mar Thoma Church, Sonnahalli, Karnataka.

Sunday School Anniversary was held on August 27th after worship service.

Prizes were distributed to the students those who won 1st to 3rd place in the following competitions: Overall Class Test, Singing, Storytelling (English and Malayalam), Elocution, Bible Quiz, Coloring/Drawing, and Memory Verse. Rev. Bibi Mathew Chacko presented the prizes to the students. Students that won 1st place in Singing, Storytelling, and Elocution represented our church for Southeast Regional Talent Fest on November 4th. The first 5 students who won the Bible Quiz represented our church as a team for the Regional Talent Fest.

Student Dedication services were on August 6th and August 27th and Teachers' Dedication on August 27th as well.

Teacher's Prayer Cell: Occasionally our teachers met after their Sunday school classes for 15 minutes to pray for our students, our sick ones and for those who are in need. There were a total of 6 prayer meetings this year.

The Southeast Regional Talent Fest 2023 was hosted by Philadelphia Mar Thoma Church. We had 29 students who attended the regional talent fest. By God's grace we received 2nd Place in Quiz and for individual performances we received 8 Golds, 15 Silver and 5 Bronze. Our group choir sang beautifully. We would like to extend our sincere thanks to the following people who supported our children with the Regional Fest Competition: Mr. Aji Thomas and Mr. Manoj Mathew for preparing the Bible Quiz competition team. The team included: Aaron Thomas, Diya John, Abel Anoop, Sahil Thomas and Rayhan Mathew. Mr. Eype John and Mr. Sumesh John for their time and dedication in sincerely teaching and preparing our students to sing harmoniously for the regional fest. The choir members were Abel Anoop, Aaron Samuel, Angeline Varghese, Alison Abraham, Alisha Samuel, Katelyn Varghese, Diya John, Nivedh Bibi, Angel Anoop, Niya Soji, Jasmine Philip, and Aisha Abraham. Also, to Mrs. Shinzy, Mr. Sumesh and Mr. Aji for taking our quiz and choir participants for a fun day at Sky Zone as a treat from Sunday School for their hard work.

Teachers' Retreat/ Appreciation Day was conducted on September 9th from 9:20 am to 1:30 pm. Bibi Achen gave a message from St. John 17, verses 4,6 and 9 and reminded us that we are chosen by God as teachers. Rev. Prince Varghese Madathileth was the guest speaker. Prince Achen talked about the Stages of Faith by James Fowler. Prince Achen urged us to encourage our students to talk more of their doubts, be open to your students, be observant of their behavior and be a good listener instead of being judgmental. Achen spoke from St. Luke 15. Achen led small group discussions about the James Fowler method which really got everyone's keen attention and was a very effective group discussion. There were 36 teachers who attended the retreat. Teachers were presented with a coffee cup with special writings to show our appreciation for their dedication. The 7 new teachers were recognized, and they were given a pen and a bookmark.

Sunday School conducted Trunks of Promises on October 22nd. 13 trunks were decorated with bible stories. All the children from pre-nursery to 12th grade were involved .
